DOLA stands for Dog Off Leash Area, and it is a space for dog owners to go to, to freely let their dogs play with other dogs. The area is relatively big, but doesn't have a gate.

I went there at 5 o'clock on a Wednesday, and stayed until 6-6:30 ish. These are the photos I got.

Image 1: Scout

Scout's owner, Kaushal is an Indian teenager who likes dola because dogs can make friends. She started coming around november, and is concerned about if the City disapproves of Jollyman DOLA.



Image 2: Feynman

Feynman's owner, Indra, is an Indian mother who comes to dola because her daughter has volleyball at Jollyman park. She didn't know about the fact that DOLA is only a trial at the moment. Her dog is 3-4 years old, but still acts like a puppy, she said.



Image 3: Peaches

Peaches' came with her owners, an Indian father-daughter pair, Sia and Sumant, to Jollyman park in 2020 December, and likes her dog to socialise with other dogs. Sia said that Jollyman DOLA is in a convenient spot, as it is much bigger than some closed areas. DOLA is not a closed area.

Dog owners try to keep their dogs inside the barriers, made up of signs like these.

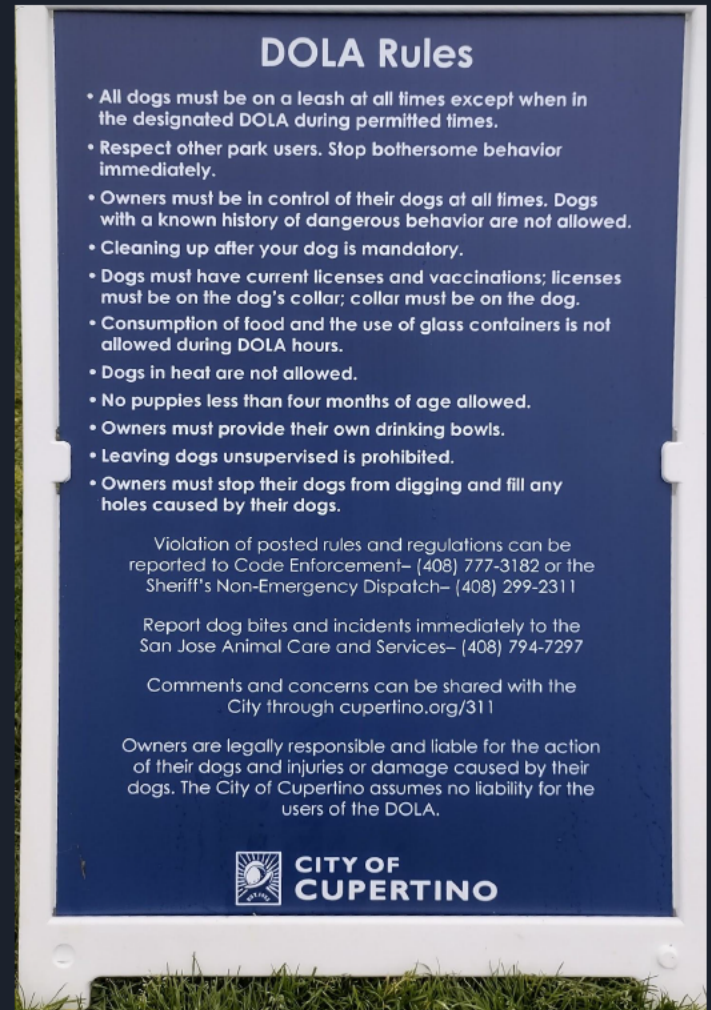


Image 8: Poop bags (?)
