- Include Bicycle Pedestrian Commission Motion from March 2022 on the City's Bicycle Pedestrian Commission website, and make other changes as necessary for consistency;
- Staff to look for opportunities to bring appropriate development projects with an impact on transportation improvements to the Bicycle Pedestrian Commission for review.
