MOTION: Eschelbeck moved and Madhhipatla seconded to approve the ATP draft materials as presented today, with the following set of modifications:

1. Address the inequality or imbalance between ranking of projects in the ATP and the Cupertino Vision Zero high injury network by reducing the max score for being on a safe route to school to 10 for all three matrices, reducing the goal max score for access from 30 to 20 and increase HIN max scoring to 30.
2. Eliminate 1.25 modifier by making balance in bicycle matrix to a negative score.
3. Consider ATP project clustering as appropriate for future ATP updates.

3. Subject: Torre Ave/Town Center Lane Pedestrian Crossing (Dullu)
