A RESOLUTION OF THE CUPERTINO CITY COUNCIL ACCEPTING UP TO \$233,963 IN COMMUNITY RESILIENCE GRANT FUNDING FROM SILICON VALLEY CLEAN ENERGY; AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS TO ACCEPT THE GRANT FUNDING AND PURCHASE OF ELECTRIC VEHICLE AUTONOMOUS RENEWABLE CHARGE UNITS WITH TRAILER FROM BEAM GLOBAL; AND APPROPRIATING MONIES FOR THE PROCUREMENT

WHEREAS, Silicon Valley Clean Energy (SVCE) launched a community resilience program that provides \$5 million in grants to member jurisdictions to plan and develop resiliency projects.; and

WHEREAS, the eligibility of projects must support a critical facility and/or provide community services during a power outage; enable self-sufficient access to power during an outage, or decrease the risk of power outages; and be zero carbon; and

WHEREAS, the City will use the grant funds from SVCE to purchase two Electric Vehicle Autonomous Renewable Charger (EV ARC) units and trailer that will provide the community with reliable power source during a disaster or power outage; and

WHEREAS, approving budget modification #2324-316 increasing the estimated revenue in 100-87-829 440-428 and appropriating \$233,963 from the General Fund 100-87-829 900-990 for procurement EV ARC units and trailer is necessary prior to reimbursement of the approved grant funds; and

WHEREAS, the City Council does hereby authorize the City Manager to execute any and all documentation necessary to accept the grant funding.

WHEREAS, the City Manager has determined that the balances from the funds specified in this resolution are adequate to cover the proposed amended appropriations, and therefore recommends the fund reallocations described herein.

NOW, THEREFORE, BE IT RESOLVED that the City Council does hereby approve the recommended fund allocations and ratifies the attached amended appropriations as set forth in Exhibit A.
