## A RESOLUTION OF THE CUPERTINO CITY COUNCIL ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2025-26 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimate \$1,583,075 in RMRA funding in Fiscal Year 2025-26 from SB 1; and

WHEREAS, This is the ninth year in which the City is receiving SB1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City uses a Pavement Management System to develop the SB1 pavement project lists to ensure revenues are being used on the most high priority and cost effective projects; and

WHEREAS, the funding from SB 1 will help the City maintain and rehabilitate multiple streets/roads; and

WHEREAS, the 2023 California Statewide Local Streets and Roads Needs Assessment found the City streets and roads are in "good" condition and this revenue will help us maintain the overall quality of our road system; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with focus on basic maintenance and safety, and investing in complete streets infrastructure, will have significant benefits citywide.

Project Description: Design, Engineering and Preparation of Contract Documents for Pavement Rehabilitation including asphalt overlay and patch repairs.

Project Location: City of Cupertino - various streets

Project Phase: Pre-Construction

Project Schedule: August 2025 – May 2026

Estimated Useful life: 15 Years

Project Title: 2025/26 Pavement Maintenance Phase 2

Project Description: Design, Engineering and Preparation of Contract Documents for Pavement Preservation including crack seal, slurry seal and fog seal.

Project Location: City of Cupertino – various streets

Project Phase: Pre-Construction

Project Schedule: February 2026 – June 2026 Estimated Project Useful Life: 2 to 7 years
