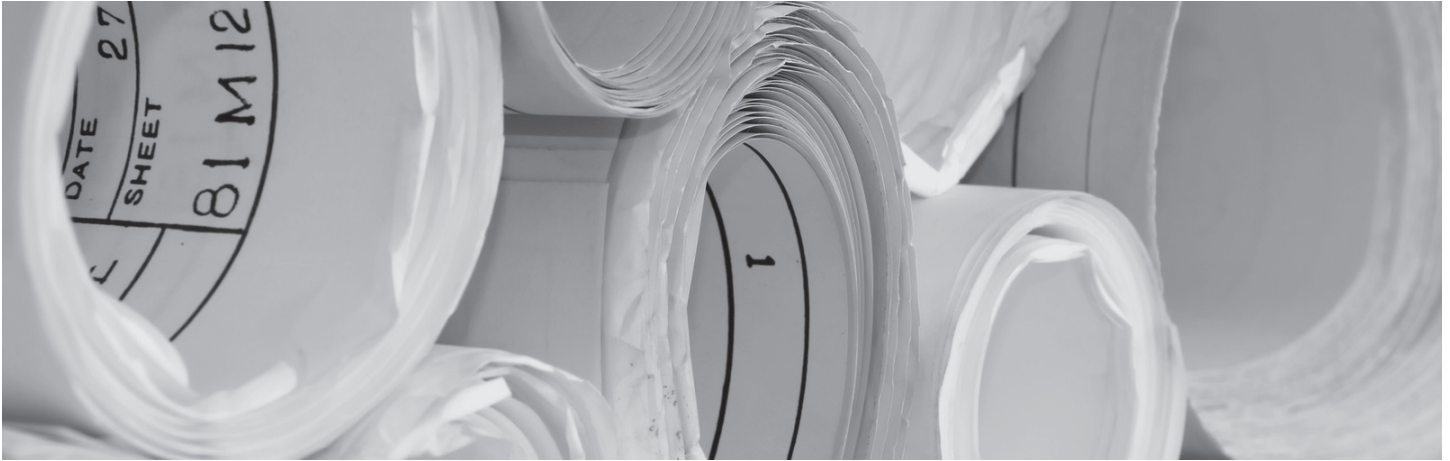

D. ON-CALL SERVICES APPROACH



Quality building, fire, engineering and CASp plan reviews are provided with the following structure:

- ▶ **What:** Our plan reviewers clearly explain in a comment letter what is not in compliance with the plans, details and specifications. In addition, our plan review team will cater their comments based on their audience (i.e. designer, homeowner, engineer, architect or contractor)
- ▶ **Where:** Comment letter will clarify which sheet, detail, etc. where on plans comment refers to
- ▶ **Why:** A code section is cited to explain why the plans/details are not in conformance
- ▶ **How:** The plan reviewer will be able to communicate with the applicant how to resolve the issue when questions arise from the applicant or staff members

ICCI is independent, properly licensed to practice in California, and has no conflict of interest with regard to any other work performed by the firm for the City of Cupertino.

ICCI embraces new technology and since its establishment in 2018, the company is mostly cloud-based with the option for all employees to be mobile. ICCI's personnel have performed electronic plan review for nearly 6 years using several permitting and workflow applications, such as ProjectDox, OpenGov, Accela, and DigEplan. Both ProjectDox and OpenGov have Bluebeam Revu built into the applications. ICCI's plan review staff also has experience performing plan review within the DigEplan platform and all our plan review staff is proficient in Adobe Acrobat Pro. In 2020, most jurisdictions transitioned to electronic plan review and ICCI was able to continue providing plan review services and accommodate any changes to the process from hardcopy submissions. Some of our clients were not prepared or equipped to receive high volumes of electronic plans. ICCI can and has offered its clients a project management site to receive, retrieve, and upload electronic documents in one secure location.
