WHEREAS, on October 9, 2020, the City issued a Request for Proposals for Residential and Mixed-Use Design Standards; and

WHEREAS, on October 30, 2020, RRM Design Group submitted a Residential and Mixed-Use Design Standards proposal in accordance with the City's Request for Proposals; and

WHEREAS, on December 18, 2020, staff conducted a thorough review and selected RRM Design Group as the preferred lead consultant for the project; and

WHEREAS, staff is recommending that the Council award a consultant agreement for the Residential and Mixed-Use Residential Design Standards Work Program item for the FY 20-21; and

WHEREAS, staff is recommending that Council authorize the City Manager to execute a consultant agreement with RRM Design Group to provide services to the City for the preparation of residential and mixed-use design standards for the Council's consideration, for an amount not to exceed \$226,757; and

WHEREAS, staff is requesting Budget Modification #2021-114 to increase project appropriations in 100-71-702 750-090 by \$75,757 for the FY 20-21; and
