Mr. Mitchell provided an update:

Adaptive Traffic Signaling and Multimodal Traffic Count: The equipment has been installed, configured, and operating. Staff will begin analyzing data at the end of June 2022.

The intersections involved are:

- DeAnza & Mariani
- DeAnza & 280N
- DeAnza & 280S
- DeAnza & Homestead

Climate Monitoring and Noise Measurement: City staff have retained Envirosuite, and encumbered funds to initiate the pilot project. The pilot consists of monitoring Pollution and Noise Environments in the area adjacent to Lehigh and Stevens Creek Quarry. There will be a public portal for residents to access data.

The Commission thanked Mr. Mitchell for the informative update.

Dear Members of the TICC,

Under your Proposals for FY 2022-2023 City Work Program, row 3: Public Safety: Research available Technology to increase Public Safety

SUGGESTION #1: Please look into the possibility of making the pedestrian walk signals at major intersections turn on maybe 5 seconds before the traffic light turns green in the same direction.

REASON: When vehicles are waiting to turn right and there are pedestrians waiting to cross, both the traffic light turns green at the same time the pedestrian light says it's okay to cross. This is a very dangerous time for pedestrians.

SUGGESTION #2: Please look into the possibility of installing the big electronic no-right-turn-on-red signs and all signals red to allow crossing in all directions (even diagonal) at some key intersections...possibly at Finch and Stevens Creek.

REASON: Recently these changes were installed at Homestead Rd. and Mary Ave. during the times that school is starting and ending. It's very clear, visible and seems to be a much safer arrangement. Drivers going north on Homestead and wanting to turn right onto Mary Ave can do right-on-red when school is not in transition but when school is starting/ending, it is very clear that right-on-red is not allowed.
