The January 2019 fire reports for the Cupertino Public Safety Commission are enclosed.

Significant Events (Last Month): Significant events for last month include:

19-0050012: Structure Fire: This event was a structure fire involving a gas station in the 19000 block of Stevens Creek Boulevard. No injuries to responders or civilians were reported. The fire caused an estimated \$125,000 in damages and the cause is under investigation.

1. <u>Situation Found</u> (Last Month): This table provides the volume and percentage of all code two and three calls by incident category.

2. <u>Average Response Times Analysis</u> (Last Month): This table provides the average response times and call volumes into each station's area, categorized by urban or rural zoning of the incident location. Also included are average response times by all CUP units.

6. <u>Community Education Events</u> (Last Month): This table shows the total number of events, personnel, and attendees at educational events.

7. <u>Incident Types</u> (Last Month): This pie chart provides a breakdown of the number of calls by incident category.






