After we collect the required number of signatures (10% of Cupertino voters) for all 4 documents, the Vallco Specific Plan will be voted on in a future election. Cupertino residents will have a chance to vote to decide if they accept the plan. It could also be adopted by City Council directly.

If the current Vallco plan is rejected by voters. will the next one be even bigger and denser? Developers must follow the General Plan, even those applying SB 35. However, the Cupertino Cito Corneil amended the General Plan to allow projects - which is the real problem. After the election, with a pro-resident majority on City Council. they can adopt

policies to regulate developers.

3. Who can sign the referendum? Who can help and who can donate? Only registered voters living in Cupertino can sign this referendum.
