Housing Commissioners,

As I review the Westport senior housing proposal that was approved by the Planning Commission in May, and is now returning yet another go-round on July 14, I realized that the city has not included **strategies for senior housing** in either the Housing Commission Work Plan or the City Work Plan. As I listen to the city council deliberate on various ordinances, lack of consideration of the impact on senior housing is appalling. It's too expensive to build ADU's for an aging parent/grandparent. Zoning laws for single-family residences preclude multifamily homes, and there were ZERO approvals of multifamily homes in 2019.

There is no recognition of the need (nor apparently the expertise) for licensed independent living, assisted living, and memory units. The BMR manual has an inherent bias against seniors and the disabled by including employment in Cupertino in the point system - these populations aren't working but need housing. In fact, the BMR manual does not even mention senior housing, and it is also biased against the same populations. The current BMR manual explicitly states that "BMR units shall be dispersed throughout the residential project", but both funding sources and wrap-around services for these groups require adjacency of units.

Seniors occupy a significant number of residences in Cupertino - 6.595 households have a resident over the age 60+ according to the census. That's approximately 1/3 of the 20,181 households. Yet there are only 585 senior units available in the city. So seniors are stuck in their too-large family homes, occupied by 1-2 people, because of the lack of senior housing for downsizing contributing to the less than 2% housing turnover in 2019.

I urge you to incorporate <u>strategies for seniors into work plans for the Housing</u> <u>Commission, as well as the other commissions and City council.</u>
