CITY COUNCIL STAFF REPORT

Meeting: June 18, 2019

Subject

Brush Abatement Program hearing to consider objections to proposed removal of brush and order abatement of the public nuisance and potential fire hazard pursuant to Cupertino Municipal Code (Section 16.40.320) regarding Defensible space (brush) and Resolution No. 19-057.

Recommended Action

- 1. Conduct Brush Abatement Program hearing to note objections of property owners having their name on the list of properties that have been non-compliant in removing brush; and
- 2. Adopt the Draft Resolution ordering abatement of public nuisance and potential fire hazard pursuant to Cupertino Municipal Code (Section 16.40.320) regarding Defensible space (brush) and Resolution No. 19-057.

Discussion

Cupertino Municipal Code Section 16.40.320 requires property owners in the locally adopted Wildland-Urban Interface Fire Area (WUI) to maintain effective defensible space by removing brush, flammable vegetation and combustible growth when required by the fire code official due to steepness of terrain or other conditions. The Cupertino Brush Abatement Program is a separate program from the County Weed Abatement Program and authorizes the County Fire Department to remove the brush if the property owner doesn't, and to recover the costs of abatement. Notice of the brush abatement program and hearing was sent to the property owners on the notification list as prepared by the Santa Clara County Fire Department (County Fire).

On May 21, Council adopted Resolution No. 19-057 declaring brush to be a public nuisance and potential fire hazard and setting a hearing date of June 18 to hear property owners having any objections to the proposed removal of brush. The attached Parcel Abatement List is a report of non-compliant properties with Wildland Safety Regulations provided by County Fire after inspections.

The initial letter regarding Wildland Urban Interface (WUI) Enforced Safety Regulations related to flammable vegetation abatement was mailed to all Cupertino property owners

on February 15. This letter notifies owners of their responsibilities and the inspection dates for compliance, and requires owners to return an information card indicating the status of their property before April 1. After this deadline, property owners not in compliance are notified of what work needs to be completed to comply with the Enforced Safety Regulations. On June 1, County Fire began conducting re-inspections of the properties that were out of compliance at the time of the first property inspection. The attached Brush Hearing Letter is sent only to those properties that did not comply with the WUI Enforced Safety Regulations upon inspection. The letters are mailed beginning June 1 and continue until the June 18 hearing date.
