## CITY COUNCIL STAFF REPORT

Meeting: February 16, 2021

## **Subject**

Consider and act on Ordinance No. 21-2200 adopting Municipal Code Amendments to update existing Mobile Vending regulations, including conforming edits to Titles 5 and 13 in the Municipal Code, adopting new regulations for Sidewalk Vending in compliance with SB 946. (Application No.: MCA-2020-004; Applicant: City of Cupertino; Location: City-wide)

#### **Recommended Action**

Conduct the Second Reading and enact Ordinance No. 21-2200 "An Ordinance to Amend Chapters 5.04, Business Licenses Generally, Chapter 5.20, Solicitors, Chapter 5.48, Mobile Vendors, and Chapter 13.04, Parks" (Attachment A).

#### **Discussion**

On January 19, 2021, the City Council introduced and conducted the first reading of Ordinance No. 21-2200 on a 5-0 vote. The ordinance was considered for a second reading on February 2, 2021. However, at that meeting, to address concerns from the public about sidewalk vending during special events at public parks, the Council made additional amendments to the draft ordinance. Specifically, the amendments prohibit sidewalk vending within 500 feet of a farmers' market, swap meet, or permitted special event. Attachment A reflects the draft ordinance with the language added by Council during the hearing on February 2, 2021. As a result of this change, the Council conducted a first reading of the ordinance, with a second reading scheduled for this February 16, 2021 meeting.

#### Environmental Review

The proposed ordinance is exempt from environmental review under the California Environmental Quality Act ("CEQA") Guidelines Section 15061(b)(3) because it has no potential for resulting in physical change in the environment, either directly or indirectly. In the event that the proposed ordinance is found to be a project under CEQA, it is subject

to the CEQA exemption contained in CEQA Guidelines section 15061(b)(3) because it can be seen with certainty to have no possibility of a significant effect on the environment.
