Conduct the first reading and adopt Ordinance No. 17-2169 entitled "An ordinance of the City Council of the City of Cupertino adding Chapter 10.84 titled "Medicinal and Adult Use of Marijuana" to Title 10 of the Cupertino Municipal Code; amending Section 19.08.030 to repeal Definitions related to Marijuana; and amending Chapter 19.98 to reference the newly adopted ordinance" (Attachment A.)

Principal Planner Piu Ghosh reviewed the staff report.

Captain Urena from the West Valley Sheriff Substation talked about concerns over marijuana use and supported adopting the draft resolution. He answered questions from Council.

Sinks moved and Chang seconded to find that the proposed actions are exempt from CEQA. The motion carried unanimously.

Sinks moved and Chang seconded to adopt Resolution No. 17-114 approving the Fifth Amendment to the employment contract for the City Manager and authorizing the Mayor to execute the contract and adopt Resolution No. 17-115 amending the Appointed Employees' Compensation Program to reflect changes in compensation for the City Manager. The motion carried unanimously with Paul voting no.
