A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUPERTINO ADOPTING THE SANTA CLARA COUNTY OPERATIONAL AREA HAZARD MITIGATION PLAN UPDATE OF 2017, WHICH WILL GUIDE THE CITY'S HAZARD MITIGATION EFFORTS AND WILL ENABLE THE CITY TO APPLY FOR HAZARD MITIGATION GRANT FUNDS

WHEREAS, all of Santa Clara County has exposure to natural hazards that increase the risk to life, property, environment and the County's economy;

WHEREAS, pro-active mitigation of known hazards before a disaster event can reduce or eliminate long-term risk to life and property;

WHEREAS, the Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre- and post-disaster hazard mitigation programs;

WHEREAS, a coalition of several cities, towns, special districts and the County of Santa Clara with similar planning objectives has been formed to pool resources and create consistent mitigation strategies within the Santa Clara County Operational Area planning area;

WHEREAS, this coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy;

WHEREAS, once the hazard mitigation plan update of 2017 is adopted by all of the Santa Clara County Operational Area jurisdictional partners and approved by FEMA, this partnership will collectively and individually become eligible to apply for hazard mitigation project funding from both the Pre-Disaster Mitigation Grant Program (PDM) and the Hazard Mitigation Grant Program (HMGP);

WHEREAS, upon adoption of Volume 1 and City of Cupertino Annex of Volume 2 of the Santa Clara County Operational Area Hazard Mitigation Plan Update of 2017 (HMP) and subsequent approval of said plan by CalOES and FEMA, the City of Cupertino will be eligible to apply for specified Hazard Mitigation Grants.

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Cupertino City Council hereby adopts the sections of the Santa Clara County Operational Area Hazard Mitigation Plan Update of 2017 (HMP), which apply to the City of Cupertino. (Volume 1 in its entirety, and Volume 2 the Introduction, the Cupertino Local Hazard Mitigation Plan jurisdictional annex (Chapter 3) and the appendices.
- In accordance with the adopted Updated 2017 HMP, the City will use the Plan to guide the City's - disaster mitigation actions, and to coordinate the strategies identified in the HMP with other planning programs and mechanisms under its jurisdictional authority

The City will continue to support the Santa Clara County Hazard Mitigation Plan Steering Committee and to participate in the planning partnership as described by the HMP (Incorporated municipalities (cities, towns and the county) and special purpose districts). Furthermore, the City will help to promote and support the mitigation successes of all HMP Planning Partners.
