PUBLIC MEETING ITEMS

1. Hyatt Hotel public art proposal Staff presentation: Erick Serrano, Applicant: KCR Development

Project planner Erick Serrano presented the staff report and introduced the artist, James Moore. The proposed art consists of a three welded structural aluminum sculptures to be located in an open seating area adjacent to the pool and hotel. Commissioners reviewed the sample materials provided and asked questions of staff and the artist regarding lighting and the estimated date of completion, including any plans for unveiling the art. Chair Sanchez motioned with a second from Commissioner Chokshi to approve the public art application, subject to conditions of the draft resolution.
