U-verse Programming Changes

AT&T contracts with programmers for the content displayed on U-verse TV® service periodically expire, or may be terminated, but are usually re-negotiated or extended with no interruption or change for our U-verse members. Additionally, from time to time it is necessary to change channel line-ups as well as television package contents. The programming changes set forth below may occur as follows:

September 2018:

As previously noticed, AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel locations to channels between 9501 – 9599, and if reasonable longer term agreements cannot be reached with the programmers, we may lose the rights to carry them (listed in alphabetical order) in or after September 2018:
