U-verse Programming Changes

AT&T contracts with programmers for the content displayed on U-verse TV* service periodically expire, or may be terminated, but are usually re-negotiated or extended with no interruption or change for our U-verse members. Additionally, from time to time it is necessary to change channel line-ups as well as television package contents. The programming changes set forth below may occur as follows:

March 2019

As previously noticed, AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel locations to channels between 9501 – 9599, and if reasonable longer-term agreements cannot be reached with the programmers, we may lose the rights to carry them (listed in alphabetical order) in or after March 2019: BET (Black Entertainment Television) (channel 155 and 1155 in HD); BET (Black Entertainment Television) - West (channel 156 and 1156 in HD); BET Gospel (channel 516); BET Her (channel 515); BET Jams (channel 508); BET Soul (channel 522); CMT (Country Music Television) (channel 525 and 1524 in HD); CMT – West (Country Music Television) (channel 526 and 1526 in HD); CMT Music (channel 527); Comedy Central East (channel 140 and 1140 in HD); Comedy Central West (channel 141 and 1141 in HD); LOGO East (channel 183); LOGO West (channel 184); MTV (Music Television) (channel 502 and 1502 in HD); MTV Live (channel 1505 in HD); MTV West (Music Television) - West (channel 503 and 1503 in HD); MTV Classic (channel 520); MTV Classic - West (channel 521); MTV2 (channel 504 and 1504 in HD); MTV2 West (channel 505 and 1505 in HD); mtvU (channel 510); NFL Network (channel 630 and 1630 in HD); NFL RedZone (channel 1629 in HD); Nick Jr. (channel 320 and 1320 in HD); Nick Jr. West (channel 320); Nick2 (channel 316); Nickelodeon East (channel 314 and 1314 in HD); Nickelodeon West (channel 315 and 1315 in HD); NickMusic (channel 509); Nicktoons (channel 318 and 1318 in HD); Nicktoons West (channel 318 and 1318 in HD); Paramount Network East (channel 145 and 1145 in HD); Paramount Network West (channel 146 and 1146 in HD); TeenNick (channel 322); TeenNick - West (channel 322); Tr3s (channel 506 and 3142 in HD); Tr3s - West (channel 507 and 3144 in HD); TV Land East (channel 138 and 1138 in HD); TV Land West (channel 139 and 1139 in HD); VH1 (channel 518 and 1518 in HD); VH1 – West (channel 519 and 1519 in HD); and World Fishing Network (channel 1679 in HD).

April 2019

As previously noticed, AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel

locations to channels between 9501 – 9599, and if reasonable longer-term agreements cannot be reached with the programmers, we may lose the rights to carry them (listed in alphabetical order) in or after April 2019: A&E (channel 132 and 1132 in HD); A&E – West (channel 132 and 1132 in HD); Crime & Investigation Network (channel 163 and 1163 in HD); FYI (channel 272 and 1272 in HD); FYI - West (channel 272 and 1272 in HD); History (channel 256 and 1256 in HD); History – West (channel 256 and 1256 in HD); History en Espanol (channel 3104 in HD); Lifetime Real Women (channel 364); Lifetime Television (channel 360 and 1360 in HD); Lifetime Television - West (channel 361 and 1361 in HD); LMN (channel 362 and 1362 in HD); LMN – West (channel 362 and 1362 in HD); Military History Channel (channel 276); Pursuit HD (channel 1644 in HD); Sportsman Channel (channel 642 and 1642 in HD); Viceland (channel 257 and 1257 in HD); and Viceland - West (channel 257 and 1257 in HD).

Effective April 30, 2019, the following U-verse applications will no longer by available to U-verse customers:

- 1) FITFUSION TV Featuring Jillian Michaels STB application (Ch. 440/633 and 1440/1633) and Interactive Menu,
- 2) Tumblebooks STB TV application (Ch. 345/1345) and Interactive Menu, and
- 3) U-verse Games STB TV application (Ch. 93/1093 and 321/1321) and Interactive Menu.

May 2019

AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel locations to channels between 9501 – 9599, and if reasonable longer-term agreements cannot be reached with the programmers, we may lose the rights to carry them (listed in alphabetical order) in or after May 2019: Canal 22 (channel 3022 in HD); Canal Once (channel 3011 in HD); HITN (channel 3055 in HD); and PX Sports (channel 3122 in HD).

Customers will be provided with written notification of the above: customer bills include a message referring them to the Legal Notices in USA Today on the first and third Tuesday of each month, and to the AT&T website att.com/u-verseprogrammingchanges, for information on programming changes.
