1. Modify slide 12 content McClellan Road Bike Corridor to be identified as Class IV bike lane
2. Linda Vista Trail will be designated as Bike & Pedestrian shared use – use project
3. Eliminate Bicycle Boulevard item from funding table
4. In updated presentation to City Council, indicate Bike Boulevard 5 project temporary ballard phase project in 2019 and final in 2020

Commissioner Lindskog seconded the motion.

The motion passed 4-0-1 (Heller absent)
