Paul moved and Scharf seconded to read Ordinance No. 19-2192 by title only and that the City Clerk's reading would constitute the first reading thereof with amendments to Chapter 13.08.080 B3 and Section III, Section 3 as per the desk items and the following additional amendments: Strike row indicating "10+" in column labeled "Density (DU/acre)" in Table 13.08.050; amend language to Section 13.08.050 F4 to state, "All dedicated land must be at least 50 feet wide in any horizontal dimension..."; add language to Table 13.08.080 under "Mandatory Element" to state that "All dedicated land must be at least 50 feet wide in any horizonal dimension"; request that staff consider a future nexus study on average number of persons per dwelling be proposed to a future Council Work Program item.
