Re: U-verse Programming Changes

AT&T contracts with programmers for the content displayed on U-verse TV® service periodically expire, or may be terminated, but are usually re-negotiated or extended with no interruption or change for our U-verse members. Additionally, from time to time it is necessary to change channel line-ups as well as television package contents. The programming changes set forth below may occur as follows:

July 2020

As previously noticed, the AT&T contract with the programmer for the following channels is set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if a reasonable agreement cannot be reached with the programmer the programming will no longer be available. AT&T may modify the channel location for the programming by moving them from their current channel location to a channel between 9501 - 9599, and if a reasonable longer term agreement cannot be reached with the programmers, we may lose the rights to carry them (listed in alphabetical order) on or after July 2020:

As well the following:

- 1) Fresno-Visalia area, KFSN (Channel 30 and 1030 in HD);
- 2) Los Angeles area, KABC (Channel 7 and 1007 in HD); KAZA (Channel 54 and 1054 in HD); KRCA (Channel 62 and 3024 and 1062 in HD);
- 3) San Diego area, KSDXLD (Channel 29 and 3024 and 1029 in HD); and
- 4) San Francisco-Oakland-San Jose area, KGO (Channel 7 and 1007 in HD).

In addition, on or after July 15, 2020:

- 1) Showtime Beyond (Channel 860 and 1860 in HD) will no longer be available and will be replaced by Showtime Showcase on Channel 860 and 1860 in HD;
- 2) Showtime Showcase will move from Channel 856 and 1856 in HD to Channel 860 and 1860 in HD;
- 3) Showtime Showcase - West (Channel 857 and 1857 in HD) will no longer be available;
- 4) SHO x BET (Channel 856 and 1856 in HD) and SHO x BET - West (Channel 857 and 1857 in HD) will be added.

August 2020

As previously noticed, AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel locations to channels between 9501 – 9599, and if reasonable longer-term agreements cannot be reached with the programmers, we may lose the rights to carry them in or after August 2020: AMC - West (Channel 119); AMC (Channel 119 and 1119 in HD); BBC America (Channel 122 and 1122 in HD); BBC World News (Channel 207 and 1207 in HD); CTI-Zhong Tian (Channel 3604); IFC (Channel 797 and 1797 in HD); Sundance TV (Channel 798 and 1798 in HD); WE - West (Channel 373); WE (Channel 372 and 1372 in HD); WGN America (Channel 180 and 1180 in HD); and World Fishing Network HD (Channel 1679).

September 2020

AT&T contracts with the programmers for the following channels are set to expire. While these channels will continue to be available to U-verse members so long as AT&T has the rights to carry them, if reasonable agreements cannot be reached with the programmers the programming will no longer be available. AT&T may modify the channel locations for the programming by moving them from their current channel locations to channels between 9501 – 9599, and if reasonable longer-term agreements cannot be reached with the programmers, we may lose the rights to carry them in or after September 2020: HITN (Channel 3055); MGM HD (Channel 1116); Ovation (Channel 385 and 1385 in HD); and Television Espanola (Channel 3029).

Customers will be provided with written notification of the above. In addition, customer bills include a message referring them to the Legal Notices in USA Today on the first and third Tuesday of each month, and to the AT&T website <https://www.att.com/esupport/article.html#!/u-verse-tv/KM1333754> for information on programming changes.
