CITY COUNCIL STAFF REPORT

Subject

Consideration of Award of Construction Contract for the 2021 Pavement Maintenance Phase 1 – Project No. 2021-105.

Recommended Action

Award a Construction Contract for 2021 Pavement Maintenance Phase 1 Project, Authorize the City Manager to Execute a Contract in the Amount of \$1,824,276.55 with O'Grady Paving, Inc., and Authorize the Director of Public Works to Execute any Necessary Change Orders, up to the Construction Contingency Amount of \$182,428, for a Total Authorized Contract Amount of \$2,006,704.55.

Discussion

On May 4, 2021, the City received nine bids for the 2021 Pavement Maintenance Phase 1 Project. This project provides asphalt overlay on 17 streets throughout the City and asphalt digout repairs on various streets and park pathways. A listing of these streets is included in Attachment A. Many of these streets are in residential neighborhoods and are in poor condition. The following is a summary of bids deemed responsive.

Maintaining and preserving the local streets and road systems in good condition will reduce drive times and traffic congestion, improve bicycle safety, and make the pedestrian experience safer and more appealing. This leads to reduced vehicle emissions, helping the City achieve their air quality and Greenhouse Gas (GHG) emission reduction goals.

CEQA

This item is exempt from the California Environmental Quality Act (CEQA) under 14 C.C.R. Sections 15301(c), repair and maintenance of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities.

Fiscal Impact

Award of this project will result in a fiscal impact up to \$2,006,704.55. Sufficient funds are available in account 270-85-821 900-921(Capital Outlay Pavement Maintenance) and 270-85-821 900-971 (Capital Outlay SB1). These funds were carried over from Fiscal Year (FY) 2019/2020, as the 2020 pavement maintenance activities were deferred due to the economic uncertainty brought on by COVID-19. No further appropriations are needed.
