Sinks moved and Vaidhyanathan seconded to adopt Resolution No. 16-084 with a modification to have a professional hearing officer chosen at the City's discretion and monitored by the City Attorney's Office to be the final arbiter.

The motion failed with Chang, Paul, and Wong voting no and Vaidhyanathan and Sinks voting yes.

The motion carried with Vaidhyanathan voting no. Vaidhyanathan said she voted no because she believes that the privacy of the residents is of utmost importance.
