3. <u>Subject</u>: Third study session on the Housing Element update focusing on the establishment of a housing sites selection inventory and strategies to promote the development of new housing.

<u>Recommended Action</u>: That the Planning Commission receive the report and presentation and provide input and recommendations to staff on the Housing Element update process, potential housing sites and strategies to promote housing development.

Senior Planner Luke Connolly introduced Ande Flower of EMC Planning Group who gave a presentation on the Housing Element Update identifying potential housing sites that will be used to promote Housing Development.

Commissioners asked questions and made comments which were answered by Mr. Flower, David Masenten, also of EMC Planning Group, Planning Manager Piu Ghosh, Mr. Connolly, and Mr. Woo, and discussed feedback provided by both the Commission and members of the public.

Written Communications for this item included emails which were received before the meeting and sent to the Commission.

Site Selection was refined from over 300 identified sites to 127, which are organized by neighborhood. Pipeline projects include 2,933 units divided into 8 zones. Sites not recommended for consideration were decided upon based on various factors, such as recent development in the neighborhood among other things.
